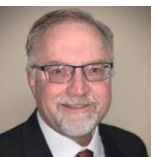
Lance Jordan, MAI, Managing Director

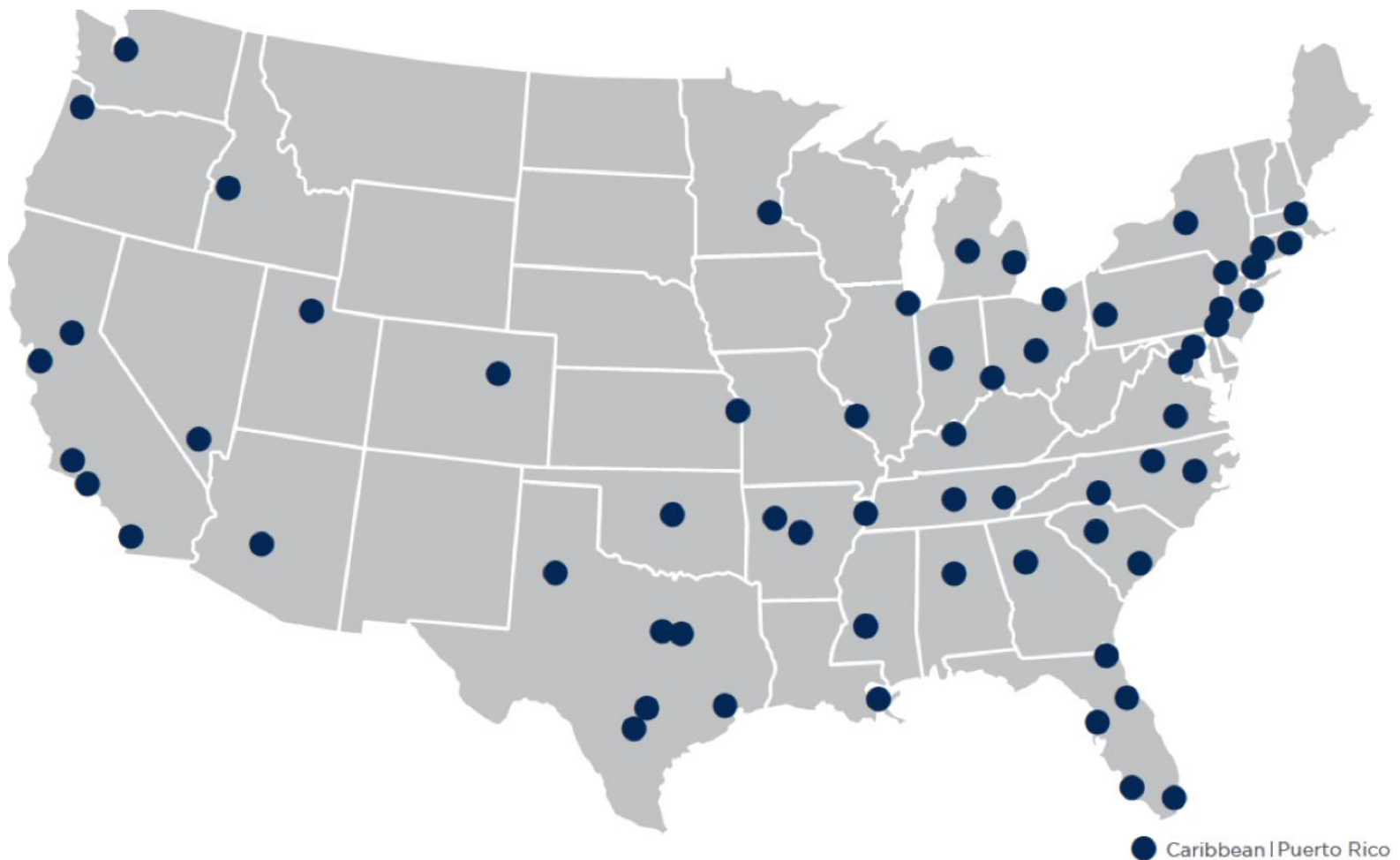
