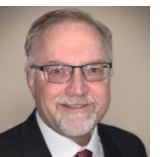
Eric Segal, MAI, Managing Director

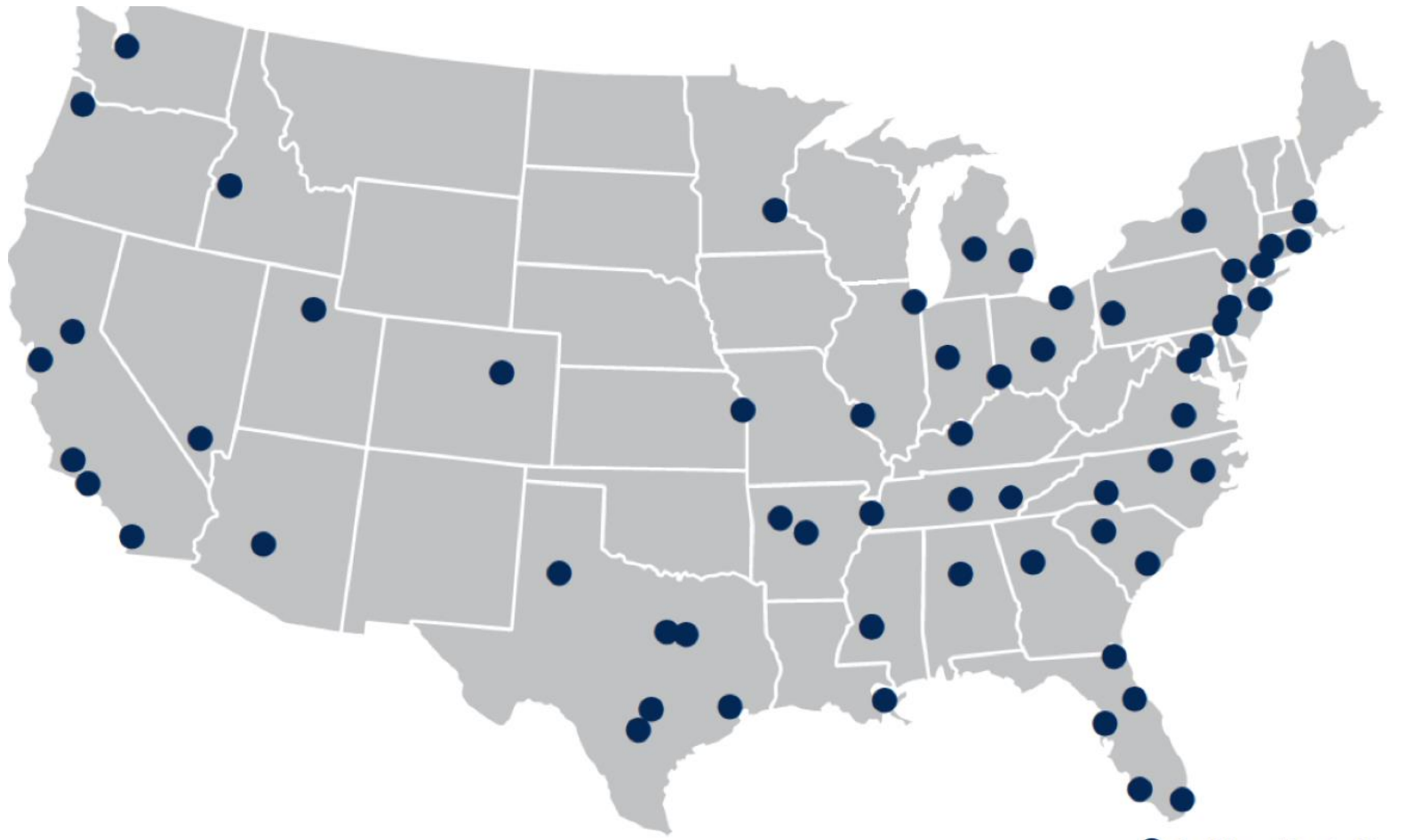
